#### Overview:

  can supply Deck Services and Industrial Specialists for their offshore Newfoundland and Labrador
  requirements.
- Supplier shall provide all management, personnel, processes, materials, tools, equipment, applicable
  certifications and facilities as may be required to ensure all equipment covered by this pending Agreement
  shall be fabricated and supplied to meet all statutory requirements, codes of practice and applicable
  specifications.
- The intention is to have this scope of work cover the requirements of the Hibernia Project\* and the Hebron Project. For clarity, the scope of work includes not only the foregoing, but may include at EMCP and/or HMDC's discretion, future work related to minor changes to the scope of work described herein, in which EMCP and/or HMDC may engage onshore or offshore Newfoundland and Labrador, for oil and gas facilities as well as exploration or subsea related activities.
- While not planned, it should be noted that the resulting RFP and Agreement may require inclusion of and/or extension to other operators in the area, project co-venturers, suppliers and/or affiliated companies.
- ExxonMobil Canada Properties, by its managing partner ExxonMobil Canada Ltd. (EMCP) and Hibernia Management and Development Company Ltd. (HMDC) may, in their sole discretion, choose to split the scope and award in whole or in part.

## **Scope of Work Overview:**

The scope of work/supply includes, but is not limited to:

- Provision of Deck Services to support all activity related to deck, crane, helideck, and stores operations on the Hebron and Hibernia platforms. Current experienced personnel complement to include Deck Leads, Crane Operators, Deck Operatives, and Stores Persons.
- Coordination of deck layout and cargo planning for both vessel and platform lifts while working with various platform functions to identify high priority cargo and bulks.
- Management of the planning and execution of heavy and critical cargo lifts to the platforms and vessels.
- Responsible for cargo backload and manifesting including, but not limited to confirmation that all backloaded materials and equipment are safe for transport.
- Completion of any required banking, rigging, and slinging of platform cargo while following the safe work practices and other procedures on each platform.
- Perform any required weekly and monthly preventative maintenance or inspection of the cranes, platform safety systems, etc. as directed by onshore or offshore EMCP or HMDC representatives.

- Experience in SAP inventory management and manifesting of equipment and materials including dangerous goods while liaising with the onshore warehousing provider.
- Current experienced personnel complement makeup the Helideck Operations Team and be responsible for assistance of personnel movement to and from helicopters, refueling of helicopters, general Helideck readiness etc.
- All Deck Services personnel to participate on emergency response teams for each platform as required.
- Industrial Specialist scope shall include, but not be limited to high pressure, ultra high pressure, NORM, etc. cleaning.
- Vendor to provide Industrial Specialist personnel who are familiar with habitat work
- Vendor personnel required to follow operational and safety platform procedures, practices, and initiatives including potential future changes to existing documentation.
- Vendor will be responsible for trade specific training and required assessments for all positions.
- Progression of continuous process improvement opportunities and innovations to support automation strategies.
- Appropriate onshore engagement of Deck Services and Industrial Specialist personnel including but not limited to training, case management, and platform visitations by vendor's management team.

Additionally, the selected supplier will be required to meet all technical and Safety, Security, Health, and Environmental (SSHE) specifications and safe work practices of EMCP and HMDC and their affiliates as appropriate.

## **Submission Requirements**

Supplier submissions in response to this Expression of Interest (including pre-qualification) **must** include the afore-mentioned reference number, as well as the following information:

- 5. Describe your experience operating under and familiarity with, the benefits provisions of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act and your experience with any similar regimes in other parts of Canada or internationally. At the NRFP/ITT stage, bidders will be required to indicate how they comply with the above.
- 6. Please acknowledge that responsible management personnel have read, understand and will support requirements to comply with the following where applicable
  - i. Section 45 of the Canada-Newfoundland and Labrador Atlantic Accord Implementation Act
  - ii. The Hebron Benefits Agreement and Hebron Benefits Plan
  - iii. The Hibernia Benefits Plan, the HSE Benefits Agreement and HSE Benefits Plan
- 7. Submitted information is to be provided in separate PDF (or native file) submissions and not submitted as one combined file. Please be aware that Company is limited to a 10MB file size for receiving e-mail. The data submitted in response to the aforementioned questionnaires will be used to evaluate your company's ability (and those of your preferred sub-contractors / suppliers where applicable) to perform these services or provide these materials. Further clarifications in the form of a meeting may be required in advance of EMCP and HMDC finalizing a bidders' list.

It will focus primarily on:

- Past safety performance
- Applicable experiences
- Available technologies with proven performance
- Current capability
- System lifecycle support capabilities and proven lifecycle programs
- Work-load
- Personnel qualifications

We will evaluate this data and develop a final list of suppliers who will be asked to submit formal competitive bids. We reserve the right to make the final determination of which suppliers will receive the Non-Binding Request for Proposals (NRFP) or Invitation to Tender (ITT) and which suppliers will be awarded the final agreement.

This Expression of Interest (including pre-qualification) is not a pre-qualification of suppliers for other EMCP / HMDC work, but is limited to the scope aforementioned. In addition, participation in this Expression of Interest (including pre-qualification), including any statements whether oral or written between EMCP / HMDC and your company, shall not create or be deemed to create any binding legal relationship or contract, or be construed to do so between EMCP / HMDC and your company. All costs associated with the preparation of your response to this expression of interest shall be at your expense.

This Expression of Interest (including pre-qualification) may or may not result in the issuance of an RFP/ITT and may or may not result in the award of an agreement. If you respond to this Expression of Interest (including pre-qualification) and your company is selected to be on the bidders' list, your company name, your designated company representative's name and business contact information may be posted on public websites. Similarly, if you are selected for award, the same information may also be posted, indicating that the work has been awarded to your company.
